## First State Investments ICVC Non-Dealing Days

This document shows the schedule of upcoming non-dealing days applicable to sub-funds and share classes of First State Investments ICVC. Table 1 lists days when there will be no dealing in shares of the relevant sub-fund because it has a material portion of its portfolio traded on a market which is closed. Table 2 shows the schedule of bank holidays in England and Wales when all sub-funds are closed for dealing. Please note that dealing instructions received for a non-dealing day will be deferred until the next dealing day.
