First Sentier Investors ICVC Non-Dealing Days

This document shows the schedule of upcoming non-Dealing Days (and non-business days) applicable to sub-funds and share classes of First Sentier Investors ICVC.

Table 1 sets out the non-Dealing Days for single country funds arising from market or stock exchange closures. As set out in the definition of "Dealing Day" in the Prospectus, it will not be a "Dealing Day" for these single country funds when the principal stock exchange(s) in which the relevant Fund invests is/are not open.

Table 2 sets out the non-Dealing Days arising for certain other funds (other than single country funds). Non-Dealing Days have been declared here because a material portion of the portfolio of these funds are invested in one or more markets which will be closed.

Table 3 sets out the non-Dealing Days arising from bank holidays in England when all sub-funds are closed for dealing.

Please note that dealing instructions received for or during a non-Dealing Day will be deferred until the next Dealing Day.
